
ECONOMIC SUMMARY - March 2019:

- The Federal Reserve convened twice during the first quarter. The overnight funds target remains unchanged at 2.50%. The last increase from 2.25% to 2.50% was during the 4th quarter of 2018. The increase on December 19, 2018 was the 4th rate increase in 2018. Previously economist were looking for potentially 2-3 hikes this year. The current outlook, based on statements from the Federal Reserve, views rates to remain unchanged for 2019. The City has already seen the effects of the forecast change, with TexPool's interest rate decreasing slightly from 2.5304% at the beginning of the quarter to 2.4164% as of March 31, 2019.
- Metro Houston created 83,800 jobs from January 2018 to January 2019 which was an increase of 2.8%. The national average during the same time period was 2.0%. The Bureau of Labor Statistics noted that in regards to the 12 largest metropolitan areas in the country, Houston ranked 3rd in the number of jobs added and tied for second with Dallas in the annual rate of job growth. The unemployment rate for the Houston MSA for February 2019 was 4.2% compared to 3.9% for the State and 3.8% nationwide.
- Consumer Price Index for the Houston MSA core based statistical area increased 0.1% in January and February and increased 0.9% over last year, for all items, which was the slowest annual increase since 2016. Excluding energy (motor fuels and electricity) and food, CPI is up 2.0% over last year.

PORTFOLIO TRANSACTIONS : For the Quarter Ended March 2019

- Total Book Value of the City's portfolio decreased by \$1,261,062 from \$30.7 million to \$29.5 million for the quarter, as operating expenditures and debt service exceeded receipts for property, sales and franchise taxes as well as charges for services. This is typical for this time of the fiscal year as the City's first of two debt service payments are due by February 1 while the second one is due August 1.
- Investments in TexPool decreased by \$1,392,607 for the quarter, from \$12.0 million to \$10.6 million as the City increased Treasury and Agency holdings by \$2 million. Cash in JP Morgan Chase Bank decreased by \$1,864,742 for the quarter, from \$2.8M to \$1.0M mainly related to debt service payment and investment purchases. As noted above, Investments in securities increased \$2 million from \$15.9 million to \$17.9 million due to investment purchases. The City's average yield to maturity increased from 1.935% in January to 2.219% by March mainly as a result of reinvesting matured securities that had been at lower yield to maturity into securities with higher yield to maturity. Yield to maturity should remain stable in March with no rate hikes on the horizon.
