
### **ECONOMIC SUMMARY - June 2019:**

- The Federal Reserve convened twice during the second quarter. The overnight funds target remains unchanged at 2.50%. The last increase from 2.25% to 2.50% was during the 4th quarter of 2018. While the prior year had 4 rate increases, 2019 has been in a hold pattern due largely to potential trade tariffs and the overall views of the economy both domestically and globally. The current outlook, based on statements from the Federal Reserve, views rates to remain unchanged for 2019 with the possibility for potential rate cuts. The City has already seen the effects of the forecast change, with TexPool's interest rate decreasing slightly from 2.4164% at the beginning of the quarter to 2.3812% as of June 30, 2019.
- Metro Houston created 86,200 jobs from April 2018 to April 2019 which was an increase of 2.8%. The national average during the same time period was 1.8%. The Bureau of Labor Statistics noted that in regards to the 12 largest metropolitan areas in the country, Houston ranked 3rd in the number of jobs added and in the annual rate of job growth. The unemployment rate for the Houston MSA for May 2019 was 3.2% compared to 2.9% for the State and 3.6% nationwide.
- Consumer Price Index for the Houston MSA core based statistical area was unchanged in May and June and increased 0.8% over last year, for all items, which was the slowest annual increase since 2016. Excluding energy (motor fuels and electricity) and food, CPI is up 1.2% over last year.

### **PORTFOLIO TRANSACTIONS : For the Quarter Ended June 2019**

- Total Book Value of the City's portfolio increased by \$3,107,056 from \$29.5 million to \$32.6 million for the quarter, as the City received \$4.5 million in bond proceeds for Virtual Gate proceeds and less operating expenditures and debt service exceeded receipts for property, sales and franchise taxes as well as charges for services.
- Investments in TexPool increased by \$6,399,956 for the quarter, from \$10.6 million to \$17.0 million as the City held off on investing matured investment proceeds into treasuries or agencies as TexPool was performing better than other investments available. Cash in JP Morgan Chase Bank decreased by \$322,191 for the quarter, from \$0.9M to \$0.6M mainly due to timing differences in cash needs at period end. Investments in securities decreased \$3 million from \$17.9 million to \$14.9 million due to TexPool currently offering a better yield. The City's average yield to maturity increased from 2.219% in March to 2.322% by June mainly as a result of reinvesting matured securities that had been at lower yield to maturity into securities with higher yield to maturity. Yield to maturity should remain stable in June with no rate hikes on the horizon.
